President:

- Wil reported that the palm tree trimming got off to a good start. - Randi discovered dying or dead pine trees by the wall near S. Patrick. Rick from Green Earth confirmed that the trees have pine borers in them.. - The board continues to obtain quotes on solutions for the bank on the retention pond as well as having received several bids on excavating. The process is very complicated.
